Overview

Sidewalk Advocates for Life (SAFL) is a peaceful, prayerful, law-abiding non-profit organization whose mission is to "train, equip, and support local communities across the United States and the world in sidewalk advocacy: to be the hands and feet of Christ, offering loving, life-affirming alternatives to all present at the abortion center, thereby eliminating demand and ending abortion."

SAFL currently has 267 locations across the globe and serves local communities through a comprehensive, 3-point, sidewalk advocacy training, tools, and support program. In its 9 year history on the sidewalk, the ministry has witnessed over 21,000 babies saved, 87 workers leave the business, and 55 facility closures among a multitude of other blessings through God's grace.

SAFL is looking for a mission-oriented, highly-motivated, detail-oriented individual who would design, develop, and implement our major gift program. You'll be responsible for managing and cultivating relationships with existing major gift prospects, as well as identifying new prospects. An ability to connect with ministry partners and clearly communicate the organization's mission and goals is key.

This is a full-time position, 35 hours a week, working remotely, with travel approximately 1-2 times per month, reporting to the President/CEO and working alongside the development director to reach financial goals.

We are unable to hire applicants outside of the United States. Please note that if you are applying in a state where we do not currently have employees, there may be a delay in your start date while we obtain the necessary paperwork for you to begin work.

Applicants must own a reliable computer, printer, and have reliable high-speed internet access and telephone service in your home. SAFL does provide a modest technology stipend to purchase necessary equipment. This stipend will be discussed with you if you are selected for an interview.

All applicants must be willing to sign and abide by our Statement of Faith, on the next page.

Job Responsibilities

- Secure mid-level and major gifts in an existing and growing portfolio alongside the President/CEO in service of the organization's long-term goals
- Help donors accomplish their philanthropic goals and ambitions through a relationship with the organization
- Work with the development department to align efforts and set goals
- Track and cultivate donors and prospects through donor database and wealth screening tools

Key Qualifications

- Passion to develop relationships, secure gifts, and meet objectives
- Excellent writing and speaking skills that compel individuals to action
- Organized, detail-oriented to efficiently track relationships and metrics
- Familiarity with Bloomerang and Donor Search a plus
- Familiarity with Google Suite, Asana, and Microsoft, Office Suite Products or ability to learn new technologies quickly
- Ability to work remotely with a flexible schedule, while generally adhering to core business hours
- Availability some evenings and weekends to visit with donors

Compensation

- Salary will be discussed during the interview process.
- Four weeks of paid time off each calendar year
- Eight weeks of paid parental leave
- Bereavement leave
- Healthcare reimbursement to cover premiums and other qualified expenses (full-time employees only)
- We do not offer a retirement plan or life insurance at this time.

Statement of Faith

Signed by SAFL Board, Staff, and Program Leaders

Sidewalk Advocates for Life is a cross-denominational, Christian organization that seeks to affirm and promote the intrinsic value of all human life from conception to natural death.

We believe in and adhere to the Bible as the inspired, inerrant, and authoritative Word of God. We further profess the following beliefs and values as necessary for living out the Gospel in our daily lives:

- We believe in the triune God who exists eternally in three persons: God the Father, God the Son, and God the Holy Spirit.
- We believe that God the Son, Jesus Christ, was conceived by the Holy Spirit, born of the Virgin Mary, was crucified, died, and was buried; on the third day he rose again; he ascended into heaven, and he will come to judge the living and the dead.
- We believe that God the Father, through His Son, Jesus Christ, calls all of us to deny ourselves, take up our cross, and follow Him, and by His grace, gifts us eternal life.
- We believe in the communion of saints, the forgiveness of sins, the resurrection of the body, and life everlasting.
- We believe that there is one church and one body of Christ, and that all believers in Christ can and should come together in a spirit of unity to promote the cause of life.
- We believe that prayer provides the foundation for all we do, and our relationship with Christ is the source of our strength.
- We believe that God has called us to obey the two greatest commandments, to love God and to love our neighbor as ourselves. In that spirit, we believe that Christ has called us to servant leadership.
- We believe God endows all human life with inherent dignity, and it must be respected and protected from conception to natural death.
- We believe God creates each person with an immutable biological sex, male or female, that reflects the image and likeness of God.
- We believe God designed marriage as a unique conjugal relationship joining one man and one woman in a single, exclusive union intended to be lifelong, and God intends sexual intimacy only to occur within that relationship.
- We believe in the sanctity of the family a father, mother, and any children as the building block of society and the church.
