Overview

Sidewalk Advocates for Life (SAFL) is a peaceful, prayerful, law-abiding non-profit organization whose mission is to “train, equip, and support local communities across the United States and the world in sidewalk advocacy: to be the hands and feet of Christ, offering loving, life-affirming alternatives to all present at the abortion center, thereby eliminating demand and ending abortion.”

SAFL currently has more than 230 locations across the globe and serves local communities through a comprehensive, 3-point, sidewalk advocacy training, tools, and support program. In its ten-year history on the sidewalk, the ministry has witnessed over 25,600 babies saved, 107 workers leave the abortion business, and 71 facility closures among a multitude of other blessings through God’s grace.

SAFL is looking for a mission-oriented, detail-oriented individual to join our team as a full-time Finance Assistant. The ideal candidate will have experience in accounting and administration and demonstrate excellent organizational and communication skills. This role requires discretion, a keen attention to detail, and the ability to work in a remote work environment.

We are unable to hire applicants outside of the United States. Please note that if you are applying in a state where we do not currently have employees, there may be a delay in your start date while we obtain the necessary paperwork for you to begin work.

Applicants must own a reliable computer, printer, and have reliable high-speed internet access and telephone service in your home. SAFL does provide a modest technology stipend to purchase necessary equipment. This stipend will be discussed with you if you are selected for an interview.

All applicants must be willing to sign and abide by our Statement of Faith, on the last page.

Job Responsibilities

- Human Resources
 - Assist in background checks, onboarding, and training new employees
 - Assist in processing payroll
 - Assist in benefit administration
 - Assist in maintaining compliance with all state laws and regulations regarding employment
 - Assist in obtaining all necessary business and tax licenses in states where we hire
- Finance
 - Manage invoices and bill payment
 - Ensure deposits are entered correctly
 - Assist in gathering information and documents for annual audit (prepared by third-party CPA firm)
 - Assist in gathering information and documents for annual tax return (Form 990) (prepared by third-party CPA firm)
 - Other finance-related administrative tasks as assigned by the Director of Finance & Administration
- Compliance
 - Assist in keeping google drive folders up to date with changing employment laws in all states where we have employees (approximately a dozen)
- Technology
 - Help answer basic tech and access questions from employees

Key Qualifications

- Proven experience in finance
- Proficiency in QuickBooks, Asana, and Google Suite
- Strong attention to detail and a commitment to accuracy
- Ability to work independently, handle multiple tasks, and adapt to changing priorities
- High level of discretion and ability to maintain confidentiality
- Alignment with the mission and values of Sidewalk Advocates for Life

Compensation & Benefits

- Salary discussed during the interview process
- Four weeks of paid time off each calendar year
- Eight weeks of parental leave for mothers; three weeks of parental leave for fathers
- Healthcare reimbursement to cover premiums and other qualified expenses (full-time employees only)

- Ability to work remotely with flexible schedule, while generally adhering to core business hours
- 401K option

Statement of Faith

Signed by SAFL Board, Staff, and Program Leaders

Sidewalk Advocates for Life is a cross-denominational, Christian organization that seeks to affirm and promote the intrinsic value of all human life from conception to natural death.

We believe in and adhere to the Bible as the inspired, inerrant, and authoritative Word of God. We further profess the following beliefs and values as necessary for living out the Gospel in our daily lives:

- We believe in the triune God who exists eternally in three persons: God the Father, God the Son, and God the Holy Spirit.
- We believe that God the Son, Jesus Christ, was conceived by the Holy Spirit, born of the Virgin Mary, was crucified, died, and was buried; on the third day he rose again; he ascended into heaven, and he will come to judge the living and the dead.
- We believe that God the Father, through His Son, Jesus Christ, calls all of us to deny ourselves, take up our cross, and follow Him, and by His grace, gifts us eternal life.
- We believe in the communion of saints, the forgiveness of sins, the resurrection of the body, and life everlasting.
- We believe that there is one church and one body of Christ, and that all believers in Christ can and should come together in a spirit of unity to promote the cause of life.
- We believe that prayer provides the foundation for all we do, and our relationship with Christ is the source of our strength.
- We believe that God has called us to obey the two greatest commandments, to love God and to love our neighbor as ourselves. In that spirit, we believe that Christ has called us to servant leadership.
